## Memorandum of Understanding on Energy and Clean Air Signed

Last July 25, the University and USAID/PA CONSULTING signed a memorandum of understanding on the Energy and Clean Air Project (ECAP) at the UC Training Center. Ms. Arlene Donaire, Deputy Chief of Party explained that the project aims to provide technical assistance to government agencies and civil society partners that are working on energy reforms and cleaner air through the generosity of a grant from USAID. Mr. Renato Goco, Chief of Party, shared that they have chosen the University of the Cordilleras as their partner in ECAP because of its track record of performance, as evidenced by a previous project with them when it was still called the Baguio Colleges Foundation.

The four-year grant involves designating UC as the Project Area Office (PAO) of the Energy and

Clean Air Project (ECAP) to help develop, implement, and monitor the progress of Clean Air activities in Baguio and Energy reform activities for Luzon. In line with this, UC has chosen former Vice Governor Edna Tabanda to be the Project Coordinator, assisted by Ms. Cecilia Agpawa.
